Purpose of Course: Public Health Management is designed to prepare future managers and leaders in the public health arena. This course will provide students with knowledge relevant to managing public health organizations while leading and motivating employees. The course will rely on organizational behavior and organizational theories to examine management topics such as management functions, activities and skills in the creation and delivery of public health programs; the organizational contexts of public health; understanding and applying management skills.

Objectives: Through participation in this course, you will

- 1. Demonstrate understanding of the managerial function
- 2. Apply managerial decision making and implementation processes
- 3. Understand managerial techniques to motivate others in the pursuit of public health objectives.

Course Materials: Journal articles and other materials will be assigned relevant to discussion of each topic. In addition, readings from the following textbook will be assigned:

- Buchbinder and Shanks, *Introduction to Health Care Management* Supplemental textbooks that may also be of interest, but not necessary:
 - Burke and Friedman, Essentials of Management and Leadership in Public Health

Other Resources: Health Science Center Library Search engines (e.g. CINAHL)

Course Grading: Several different modalities will be used to evaluate students' understanding of information presented. THE INSTRUCTOR RESERVES THE RIGHT, WITH ADVANCE NOTICE, TO MODIFY THE GRADING SCHEME TO ADDRESS COURSE PROGRESS.

Exams (30%)

A mid-term and a final exam will be administered during the semester. Both exams will be a combination of multiple choice, short answer and fill-in-the-blank questions.

Case Studies (30%)

Students will be assigned teams to complete case studies that will be discussed and reviewed in class. Specifics of case study requirements will be listed below as well as reviewed in class.

Final Project (30%)

A final project encompassing a managerial analysis will be assigned and due at the end of the semester. The final project should be 8 to 10 pages in length. Specifics of the assignment will be discussed in class and posted on Sakai.

Attendance (10%)

Attendance will be taken at every class. Students will be provided 2 unexcused absences. Absences will also be excused WITH PRIOR NOTICE for documented illness or official UF academic conflicts. Other absences may be excused at the instructor's discretion.
